## Human Rights Commission of the Maldives

Human Rights Commission of the Maldives (HRCM) requires a local consultant to develop and manage an online tool to monitor elections.

### Project Information

As the National Human Rights Institution (NHRI) of Maldives, HRCM is mandated to monitor and report on the human rights situation in Maldives. As part of this duty, HRCM will monitor the elections to assess whether the right to vote and participate in political life is guaranteed as stated in the Maldives Constitution and international treaties to which Maldives is a party, as well as to assess whether the election is free and fair. Thus, gathering information and analysing data in the upcoming presidential election requires a practical web (online) tool.

### Project Title

Development of a Web Platform used in Elections Observations

### Funding and Implementing Agency

Human Rights Commission of the Maldives (HRCM)

### Duration

1 Months

### Objectives

- Develop a practical online tool to collate and analyse data, received by elections observers and HRCM's staff.
- Evaluate data collected and produce findings as well as generate statistics on the right to vote, freedom of expression and assembly, and the right to run for public office.

### Description of Work and Outcome

1. Develop and deliver an online tool which can generate customized survey forms (similar to google form or Microsoft form)
2. The generated forms should be filled via web on mobile phones and tablets.
3. The online tool should generate both Dhivehi and English Language forms.
4. The online tool should be equipped with different categories of survey Questions (as in Google Forms). This includes, *inter alia*;
  - Text question (Text/Number);
  - Likert scale;
  - Multiple-choice question;
  - Multiple answer question;
  - Date question;
  - Rating scales; *and*
  - Ranking question
5. The online tool should be equipped to generate forms with sections based on different topics

6. The online monitoring tool should have the ability to analyze and generate statistical data from the forms created. This includes, *inter alia*;
  - Result summary sheet for the questions;
  - Analyze and compare questions separately;
  - Generate statistics based on the data gathered from various locations;
  - Analyze/filter responses in relation to other responses;
  - Equipped to generate data in to customized graphs and tables; and
  - Generate and export graphs and tables to MS Word and MS Excel.
7. To tool should have the option to export the data gathered from forms to MS Excel and other major data analysis applications.
8. The online forms generated from the tool should have the option to limit the excess to specific users.
9. The developer must engage with the HRCM official on the implementation of the online tool.
10. The developer should conduct a training session to the officials of HRCM on the application of the online tool.
11. The online tool shall have at least 1 (One) year cloud hosting subscription. This includes;
  - Minimum 2GB RAM;
  - Dedicated 1 CPU; and
  - Disc Space: 50GB.
12. HRCM must have **real-time access** to all data collected via the tool.
13. The developer should submit a user manual on the web tool to HRCM.
