



HRCM Vice President attends Regional workshop on establishing NHRIs

The Vice President of Human Rights

Commission of the Maldives, Mr. Mohamed Zahid, represented HRCM at a regional workshop to discuss issues around the establishment of National Human Rights Institutions (NHRIs) in their island states. The workshop co-organized by the Asia Pacific Forum, the United Nations Office of the High Commissioner of Human Rights and the Pacific Islands Forum Secretariat, was held in Samoa from 27-29 April 2009.

The objective of this workshop was to contribute to the dialogue on human

rights in the Pacific by engaging government representatives, parliamentarians, public officials and members of civil society groups.

The workshop also was a forum to share lessons learned from NHRIs around the region, especially the experience of NHRIs on small island states. The Vice President of HRCM Mr. Mohamed Zahid shared the experiences of the HRCM with the participants in this forum.

HRCM Vice President Observes Malawi Elections

The vice president of HRCM, MR. Mohamed Zahid was in Malawi from 11-26 May 2009, at the request of the Secretary-General of the Commonwealth, to be a member of the Commonwealth Observer Group for the election conducted in Malawi.

The Malawi election was held on 19th May 2009. The Commonwealth team consisted of eleven members, chaired by a former Head of State.

Human Rights Awareness Workshop for Facilitators of Life Skills Program



Human Rights Commission of the Maldives in collaboration with Education Development Center conducted a Human Rights awareness workshop for facilitators of the life skills program. The objective of this training was to facilitate the promotion and protection of human rights in the education sector and raise awareness on human rights and responsibilities. Sessions on Universal Declaration of Human Rights, Convention on the Rights of the Child, Human Rights and Health, Islam and Human Rights and the roles and functions of the HRCM were addressed in this training. This training was facilitated by Commission Members and staff.

Grave concern over release of suspected pedophiles



The Human Rights Commission of the Maldives issued a press release last month expressing its concern over the increase in reported cases of child abuse as well as the increasing leniency exercised by the courts in releasing suspected pedophiles without fully considering the subsequent impact of their release on the safety and security of the victims and their families.

HRCM refers to Article 49 of the Constitution, which confers on the courts

the power to keep suspects in custody if their release may endanger public safety.

HRCM believes Article 49 authorizes the courts to keep suspected pedophiles in custody and called upon the courts to fully consider the provisions of Article 49, and to exercise this power to detain suspected pedophiles in custody during the period of trial.

In addition the Commission also called upon the People's Majlis to expedite an Act on pedophiles and child abusers.

HRCM announces establishment of NGO network



HRCM has begun work to establish a network of communication and co-operation among NGOs involved in the field of human rights in the Maldives. The objectives of this endeavor are to assist and support the capacity development of NGOs, provide encouragement for existing NGOs in carrying out their activities and for new NGOs to actively participate in programs aimed at protecting, sustaining and promoting human rights. This network also aims to create strong bridges between provincial NGOs by providing a platform for regular communication and

discussion of related issues, encourage better coordination and the effective implementation of activities aimed at protecting, sustaining and promoting a high regard for human rights in the country. In addition it aspires to achieve universal access to services provided by HRCM with the assistance of focal points in Island based NGOs, set up provincial NGO connections that would provide logistical and qualitative assistance during monitoring visits by HRCM. Thus it would build a solid foundation of active island based NGOs which would assist in the set up of HRCM provincial offices in the future.

HRCM takes a public limited company to court

HRCM is to take action against Maldives Airports Company limited for not complying with a Commission order.

According to articles 36 and 26 of the Commission Act, all persons and entities within the jurisdiction of the Maldives are obligated to follow orders issued by the Commission in order to uphold the rights awarded by the constitution of the Maldives,

The case was presented to court on 19 April 2009, requesting for a court order.
